Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. The Texas Dept. of Health has declared the State of Texas under a rabies quarantine. All dogs three months and older must have a current rabies vaccination certificate. Dogs without current certificates are subject to 30 days quarantine. Tags do not constitute proof of vaccination.

ATTENTION EXHIBITORS

AKC registerable French Bulldogs are eligible to enter.

No dog that is taped or bandaged will be judged.

Refer to [Rules Applying to Registration and Dog Shows](#), Chapter 6, Section 4 through 8, for requirements for eligibility to enter the various classes.

The Show Secretary, his immediate household or immediate family members will not exhibit or act as a handler at the match. No dog owned wholly or in part by the match secretary or any member of his immediate household or family will be entered in this match. All other members of the French Bulldog Club of Dallas/Ft Worth are allowed to exhibit at this match.

No match judge or any person residing in the same household with the match judge shall exhibit or act as agent or handler at this match.

Move Ups will not be accepted at this match.

Bitches in season will not be allowed to compete at this match. The club will refund entries for Bitches shown to be in season on the day of the match.

No dog with the CDX or equivalent title or with a UD or equivalent title may compete in this match.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge or bared from competition by action of the bench show committee.

No entry fee will be refunded if the show cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, strikes, or any other cause beyond the control of the club.

Telephone, and unsigned entries cannot be accepted. Entries without the agreement and rules on the reverse side are not acceptable.
